The research aims to:

- (1) investigate the extent to which networked experiences support elearning capacity development,
- (2) identify network characteristics that motivate and support tertiary educators to engage in networked professional development opportunities, and
- (3) explore ways in which networked experiences can be effectively documented to illustrate developing elearning capacity.

Data collection for this project will continue for an estimated *36 months*. The results from this project will add to the growing literature on contemporary elearning capacity development initiatives. It will also inform the work of learning designers, academic developers and academic development units like CLeaR. Since the research is from the perspective of the educator, the outputs will help influence their elearning approach and practices to improve student learning.

The two risks associated with this research – coercion and bias – have been mediated to some extent by:

- inviting a wide range of participants and allowing anonymous, completely voluntary participation without any consequences or disadvantage from a lack of participation.
- recruiting participants outside of the University of Auckland, such as ASCILITE members.

Project Procedures

If you choose to participate, you will complete an <u>online questionnaire</u> which is anonymous. I will also require permission to interview you by asking that you inform me of your interest to be interviewed using my contact details on the questionnaire.

The expected time commitment from you for the online questionnaire will be 15-20 minutes and the interview will need 1 hour of your time at maximum.

You can choose to withdraw from participation at anytime without giving a reason. To allow for transcription and coding, the interview will be recorded and you will be provided a copy of the transcript for review. You can request to stop the recording at anytime without giving a reason and retract information if you choose to within the allowed timeframe of one month. Once the data has been de-identified, collated and coded, it will not be possible for you to request further changes. However, you do have the flexibility to choose to opt out of answering particular questions during the interview.

Data Storage, Retention, Destruction and Future Use

Data will be collected through anonymous online questionnaires and interviews. Once the set timeframe for the questionnaire has lapsed, it will be closed off to participation. Online questionnaire data will be collated and stored on disk under University of Auckland storage space for Qualtrics. The recorded interview data will be stored on disk in a secure folder on the University of Auckland network and University's official Google Drive storage for staff and students. Both these storage spaces require user authentication so the integrity of its security is assured.

The data will be stored for a minimum of six years, preferably until the completion of the requirements of the degree of doctor of philosophy. After the minimum storage time has elapsed, the data will be destroyed by deleting the questionnaire interface on Qualtrics and the storage data – media files and word transcripts – on the University network and Google Drive.

Right to Withdraw from Participation

You have the right to withdraw from completing the online questionnaire and interview at any time without giving a reason. However, though you can withdraw your interview data up to one month after it has been collected, it is impossible to withdraw data from the anonymous questionnaire once it has been submitted.

Anonymity and Confidentiality

The preservation of confidentiality is paramount. The information you share with me will remain confidential to our research team (including my two supervisors). Your anonymity will be protected via secure, anonymous status for the questionnaire and de-identification of the interview data during coding.
